## Dogs Eligible to Enter

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Indefinite Listing Privileges (ILP), or approved Foundation Stock Service (FSS) registration. (Regulations for Agility Trials, September 1, 2006, Ch. 1, Sec 3).

Dogs of a registerable breed with an acceptable foreign registration number are eligible to participate subject to Chap.11, Sec. 1 of the Dog Show Rules.

Mixed breeds, breeds not registerable with the AKC, bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance are not eligible to participate. No dog shall compete if it is taped or bandaged or in any way has anything attached to it for medical purposes. Spayed bitches and neutered males are eligible to participate. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

## Course Familiarization and Warm-Ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. The walk-through allows handlers to plan their strategy for running the course. A walk-through period will be held prior to each class. No umbrellas are allowed during walk-thrus. A warm-up area consisting of a regulation agility jump, shall be provided for all exhibitors.

**Dogs participating** must be fifteen (15) months of age or older and must be registered with the American Kennel Club or the have an AKC Limited Registration, Indefinite Listing Privileges (ILP), or approved Foundation Stock Service (FSS) registration. Dogs must be physically sound. Dogs that are blind or deaf shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Dogs under six (6) months of age are not permitted on the show grounds.

**BITCHES IN SEASON** are not eligible to participate. Entry fees will be refunded. Written verification from a veterinarian is required. **Notification for refund of bitches in season must be RECEIVED no later than 48 hrs after end of the match. A Veterinarian's note AND Final Match Confirmation for dog must accompany any such refund.** Requests can be faxed to 315-389-4607.

**Dogs may arrive** any time prior to Judging, if a copy of their jump height card was sent with their entry. Otherwise, they must be available for measuring before their class begins.

**ATTENTION CANADIAN EXHIBITORS:** Dogs whelped in Canada are eligible to enter Agility Trails using their Canadian Kennel Club Number for a 30 day period. All entry fees must be paid in U.S. funds.
